#### **CHAPTER 1: INTRODUCTION**

#### 1.1 INTRODUCTION

Council for Food Research and Development (CFRD), a project of the Government of Kerala, established in 2005 at Konni, Pathanamthitta, is a sister institution of SupplyCo. At Elanji, Ernakulam, CFRD is constructing a Fruits and vegetables dehydration and chiller unit, which is at its last phase of construction.

#### 1.2 THE CONCEPT & OBJECTIVES

The project of setting up of Fruits and vegetables dehydration and chiller unit is envisaged with the purpose of controlling.

- post-harvest waste of fruits and vegetables
- the price of fruits and vegetables throughout the year

This project will help farmers to get a good return from their harvest. Due to lack of processing facilities like this, farmers are losing a good percentage of their harvest.

In harvesting time, the price of fruits and vegetables will be low due to excess availability while in lean season their price will increase exponentially. This project will help to maintain a balance in the price of fruits and vegetables.

The Project is designed to promote Export and domestic marketing of value-added fruits and vegetables.

## **CHAPTER 2: INSTRUCTIONS TO APPLICANTS**

#### 2.1 General Instructions

- (i) The intending bidder can download EOI and Bid Proposal documents from the websites <a href="www.cfrdkerala.in">www.cfrdkerala.in</a> and <a href="www.supplycokerala.com">www.supplycokerala.com</a>.
- (ii) The Bidder is expected to examine all instructions, forms, terms of reference and can visit the plant location within the prescribed time with at least 72 hours prior intimation. They can contact the Plant Engineer (Contact No: 9400020166). Failure to furnish all information required in the Bid Proposal will be at the Bidder's risk and is likely to result in out-right rejection of the Bid Proposal.
- (iii) An Evaluation Committee in the presence of bidders will open the Bid Proposal on the date and time indicated in the schedule.
- (iv) If the envelopes are not properly sealed, the Authority assumes no responsibility for the misplacement or premature opening of the contents of the Application and consequent losses, if any, suffered by the Applicant.

(v) Failure to provide information which is essential to justify the applicants meeting the requirements or to provide timely clarification or substantiation of the information supply may result in disqualification of the applicant.

#### 2.2 Terms of reference:

- (i) The dehydration and chiller units would be handed over to the highest bidder on a lease basis.
- (ii) Successful bidder must first complete all the remaining works, listed and non listed as per plant specification (1.3), that is necessary for the successful operation/functioning of both dehydration and chiller unit as per their specifications. The bidder is obligated to do any extra work that is not mentioned in plant specification (1.3).
- (iii) After and during the completion of all the necessary pending work as per the estimate, the Evaluation Committee will certify the work done. Only after getting the approval from Evaluation Committee and getting all Government approval, Fruits and vegetables dehydration and chiller unit will be handed over to the bidder on "lease basis".
- (iv) All necessary works shall be completed and all necessary permit/license/approvals from Government shall be obtained within a period of 6 months from the date of handing over the unit as in clause (i) above.
- (v) The lease period shall be for a time of 10 years from the date of completion of the work as certified by the Evaluation Committee.
- (vi) Any delay beyond this period mentioned in clause (iv) above shall be counted as the lease period, for which the LESSEE shall be liable to pay lease amount.
- (vii) After the lease period, the fruits and vegetables dehydration and chiller unit must be handed over to CRFD. Extension of lease period for bidder can be considered based on his performance, discussion on lease amount and on mutual agreement.
- (viii) During the lease period, timely repair and maintenance of the dehydration and chiller unit must be ensured and is the full responsibility of the LESSEE
- (ix) The unit shall be subject to time to time inspections by departmental officials during the lease period.
- (x) CFRD will support the bidder administratively in obtaining statutory clearance from Panchayat and other Government agencies.

The "EOI" in the prescribed format at **Appendix:1** and "Bid Proposal" in the prescribed format at **Appendix:2**, in sealed envelope should reach the Office of the Senior Administrative Officer, Council for Food Research and Development (CFRD), Anakuthi, Perinjottakkal PO, Konni, Pathanamthitta, Kerala – 689692 on or before the designated time and date and shall be evaluated by the Evaluation Committee in the presence of authorized representatives of the individual/Agency.

# 2.3 Eligibility Criteria for Bidders

To be eligible for bidding, an applicant must submit self-attested copies of the following documents along with the Expression for Interest (EOI)

- (i) The bidder must have at least 5 years of experience in the field of fruits and vegetables **storage and processing.**
- (ii) Certificate of Incorporation/ Registration of the Firm.
- (iii) Import Export Code/certificate.
- (iv) Registration cum Member certificate from APEDA.
- (v) Valid Trade License issued by the state Government.
- (vi) Valid GST registration
- (vii) PAN CARD
- (viii) The Bidder or its sister concern must not be black listed by any Government or Public Sector Organization in India at the time of submission of the Bid Proposal.
- (ix) A short note on the strategy they proposes to utilize the facility with an undertaking agreeing to the term of reference (2.2) (i) to (x).
- (x) More weightage would be given to bidders from fruits and vegetables processing and storage industry/organization.

#### 2.4 Language of Bid Proposal.

The Bid Proposal should be written in English language. English version of Bid Proposal shall govern its interpretation.

#### 2.5 The Bidding Process

The bidding process shall comprise of the following stages:

- (i) Bidders should submit EOI along with qualifying documents.
- (ii) Pre-bid meeting with qualified candidates.
- (iii) Bidders should submit their Bid Proposal along with detailed estimate for pending work at Elanji. Pending works are listed in the Bid Proposal document and bidders are expected to visit the site.
- (iv) Evaluation of estimate and Bid Proposal by the Evaluation Committee.
- (v) Negotiation and selection of successful bidder.

# 2.6 Pre- qualification

- (i) The pre- qualification documents must be submitted along with Expression of Interest (EOI)
- (ii) The pre-qualification would be based on the documents submitted as per clause 2.3 of the bid documents. Only the bidders who qualify in all the requirements as specified in clause of the Bid Proposal document shall be eligible for pre-bid meeting.

# 2.7 Pre – Bid meeting

All parties who are qualified will be called for a pre-bid meeting. At the meeting we will have a detailed discussion regarding the pending work.

Pending work like installation and maintenance of machinery and for pending electrical work, the bidder can engage in contract with the existing CFRD contractors or can appoint a new one.

After the meeting, qualified candidates must prepare a detailed estimate for each work listed in clause (1.3), through LSGD certified engineers for completing the pending works of both dehydration and chiller unit as well as general works. The bidder must submit the license copy of engineers who prepared the estimate for each work along with the estimate to CFRD.

The Evaluation Committee will select the successful bidder based on the estimate and the Bid Proposal.

#### 2.8 Submission of Bid Proposal

After the pre -bid meeting, successful bidders can submit their detailed estimate for pending works and the filled-out Bid Proposal in a separate sealed envelope with an outer envelope that shall be super-scribed "BID PROPOSAL FOR", Leasing out of Fruits and Vegetables dehydration and chiller unit.

CFRD shall have full freedom to alter the method of accepting Bid Proposal from physical to electronic format after the Pre- Bid meeting.

#### 2.9 Period of Validity of Bids

Bids shall remain valid for 90 (Ninety) days after the deadline for submission of bids. A bid valid for a shorter period shall be rejected as non-responsive.

## 2.10 Clarification in submission of Bid Proposal

#### 2.11 Deadline for Documents/Estimates

Documents must be received by not later than the date and time specified in the time schedule. In the event of the specified date for the submission of Documents being declared as government holiday for Kerala, the document will be received up to the appointed time on the next working day.

The CFRD may at its discretion, extend this deadline for submission of EOI/Estimate/Bid Proposal by amendments.

#### 2.12 Late Bids

Any EOI/Estimate/Bid Proposal received after the deadline for submission of bids prescribed by the Procurer will be rejected and/or rejected unopened to the Bidder.

#### 2.13 Right to Accept or reject any or all Applications/Bids

Notwithstanding anything contained in this Bid Proposal, the CFRD reserves the right to accept or reject any B id P r o po s a l/Bid and to annul the Bidding Process and reject all Bid Proposals/ Bids, at any time without any liability or any obligation for such acceptance, rejection or annulment, and without assigning any reasons therefore. In the event that the CFRD rejects or annuls all the Bids, it may, in its discretion, invite all eligible Bidders to submit fresh Bids hereunder.

## 2.14 Corrigendum

Should the CFRD deem it necessary to amend the Bid Proposal Document as a result of a clarification, it shall do so by uploading the corrigendum/clarification in the website.

In order to provide prospective bidders with a reasonable time to take the amendment into account in preparing the bids, the Department may at its discretion, extend the last date for the receipt of Bid Proposal.

# 2.15 Opening of Bid Proposal.

The Evaluation Committee shall conduct the opening of Estimate and Bid Proposal in the presence of the Bidders or their representatives at the address, date & time specified in the Bid Proposal Document.

Preliminary scrutiny of the Pre-qualification documents will be made to determine whether all the required documents are in order. If any Bidder's pre-bid documents are not in order, it will be liable for cancellation.

#### 2.16 Evaluation of Bid Proposals:

- (i) All the documents will be evaluated by an Evaluation Committee constituted for this purpose by the CFRD
- (ii) The decision of the Evaluation Committee in the evaluation of the Pre-qualification, Estimate Evaluation & Bid Proposal along shall be final.
- (iii) The Evaluation Committee shall evaluate the pre-qualification documents and a pre- bid meeting will be conducted before evaluation of Bid Proposals
- (iv) Only those who qualify will be called for, in the Pre- bid meeting.
- (v) After the Pre-bid meeting, bidders are asked to submit their detailed estimate along with their Bid-Proposal.
- (vi) The decision of the Evaluation Committee on the selection of the winning Bidder will be final binding to all bidders.

#### 2.17 Bid Proposal Evaluation

- (i) Detailed estimate and Bid Proposal of bidders will be opened in the presence of authorized representatives.
- (ii) The evaluation shall be based on the amount proposed as the lease amount per month on the Bid Proposal Form.

#### 2.18 Final Selection

- (i) Selection of the bidder will be based on evaluation by the Evaluation Committee.
- (ii) The Evaluation committee shall evaluate the detailed estimate to ensure that the proposal fulfills all requirements mentioned herein. The highest bidder based on lease amount quoted in the Bid Proposal shall be selected.
- (iii) Any effort by a bidder to influence the Evaluation Committee may result in rejection of the Bid Proposal.

#### 2.19 Termination of Contract

The CFRD may without prejudice to any other remedy for breach of contract, bywritten notice of default sent to the bidder, terminate the Agreement of the Bidder.

- (i) If the bidder has been engaged in fraudulent & corrupt practices with malaise intentions in competing for or execution of the Contract.
- (ii) The Authority may at any point of time terminate the Agreement by giving 30 days written notice to the bidder if the bidder becomes bankrupt or insolvent or is blacklisted by any government/private organization in India.

# 3.0 Ownership of information:

The ownership of all the information generated will at all time rest with CFRD and the bidders will have no proprietary or other rights in respect of the same.

## 4.0 Force de Majeure:

Neither party will be liable in respect of failure to fulfill its obligations, if the said failure is entirely due to Acts of God, Governmental restrictions or instructions, natural calamities or catastrophe, epidemics or disturbances in the country. *Force de Majeure* shall not include (i) any event which is caused by the negligence or intentional action of a Party or by or of such Party's agents or employees, nor (ii) any event which a diligent Party could reasonably have been expected both to take into account at the time of being assigned the work, and avoid or overcome with utmost persistent effort in the carrying out of its obligations hereunder.

A Party affected by an event of *Force de Majeure* shall immediately notify the other Party of such event, providing sufficient and satisfactory evidence of the nature and cause of such event, and shall similarly give written notice of the restoration of normal conditions as soon as possible.

#### **5.0 Conflict of Interest:**

Participation of Bidder(s) with a conflict-of-interest situation will result in disqualification of the concerned bidders. Furthermore, the Evaluation Committee reserves the right to debar/bar bidders from all further process of empanelment.

The bidder who is a "member of family" of an Employee working in CIVIL SUPPLIES DEPARTMENT, SUPPLYCO or CFRD is not eligible for this EOI. "Member of family" in relation to an employee working in CIVIL SUPPLIES DEPARTMENT, SUPPLYCO or CFRD include:

- (i) The wife or husband, as the case may be, of the employee working in CIVIL SUPPLIES DEPARTMENT, SUPPLYCO OR CFRD, whether residing with the concerned or not, but does not include a wife or husband, as the case may be, separated from the Government servant by decree or order of a competent court.
- (ii) Son/daughter or stepson/stepdaughter of an Employee of CIVIL SUPPLIES DEPARTMENT, SUPPLYCO/CFRD, who is wholly dependent on him, but does not include a child or stepchild who is no longer, in any way, dependent on the employee working in CIVIL SUPPLIES DEPARTMENT, SUPPLYCO OR CFRD or whose custody, the employee has been deprived of, under the law.
- (iii) Any other person related, whether by blood or marriage, to an Employee working in CIVIL SUPPLIES DEPARTMENT, SUPPLYCO OR CFRD, or to Employee's wife or husband, and is wholly dependent on the Employee working in CIVIL SUPPLIES DEPARTMENT, SUPPLYCO/CFRD.

#### **6.0 Arbitration:**

Venue of arbitration will be in Ernakulam (district), Kerala and will be governed by provisions of the Indian Arbitration & Reconciliation Act. Any dispute or difference whatsoever arising between the parties out of or relating to the construction, meaning, scope, operation or effect of this contract or the validity or the breach thereof shall be settled by arbitration in accordance with the Rules of Arbitration of the Indian Council of Arbitration and the award made in pursuance thereof shall be binding on the parties.

#### 7.0 OTHER TERMS & CONDITIONS

The following terms and conditions will form the core of the Lease agreement that will have tobe signed between the **LESSOR** (CFRD) and the **LESSEE** (winning Bidder)

- (i) Taxes, Revenue and any payable charges in respect of the property will be borne by the LESSEE alone.
- (ii) The electric charges and water charges after handing / taking over of the property shall be borne by **LESSEE** alone.
- (iii) The **LESSEE** can bring his own furniture for office use, but no permanent fittings will be made inside the property until and unless permitted so by the **LESSOR**.
- (iv) The **LESSEE** shall not be allowed to transfer / sublet the present lease or allowanybody else to occupy the premises or any part thereof.
- (v) The **LESSEE** shall not be deemed to be in the exclusive occupation of the property and (the **LESSOR**) his authorized agent shall have the right to enter upon the premises at any time during working hours for inspection.
- (vi) The **LESSEE** shall maintain the demised property in good condition and will not cause any damage thereto. If any damage is caused to the demised property or any part thereof by the **LESSEE** or his employees, servants or agents, the LESSEE shall compensate as may be determined by the **LESSOR's** architecture / engineer.




